

Resolution No.12

A detailed discussion was held with respect to members of Dhole Patil Education Society. The subject to allotment of land measuring 10000 sq.meters (i.e. 2.5 Acres) at WagholiTal.HaveliDist.Pune in Gut No. 2270 A (old) i.e 1284 A (New) with school building to Dhole Patil School for Excellence (Proposed CBSE School) at WagholiTal.HaveliDist.Pune.

As per discussion in the meeting, the executive committee members unanimously observed that as per CBSE affiliation bye-laws . It is absolutely necessary to have a separate land for " Dhole Patil School for Excellence (Proposed CBSE School) at WagholiTal.HaveliDist.Pune.


In the meeting, members further unanimously resolved that Dhole Patil Education Society at Gut No. 2270 A (old) i.e 1284 A (New) comprising of single piece of land admeasuring 57200Sq.meters (say14.13 Acres / 5H 72 R) land which is owned by the society vide Gift deed registered document No 6999/2005 registered on 12/12/2005 out of which, as per CBSE requirements, **10000 sq.meters (i.e.2.5 Acres)** of land is boundary walled for permanent use of " **Dhole Patil School for Excellence** at Wagholi Tal. Haveli Dist.Pune.
